## Starting Early

Head Start is a national program that promotes school readiness locally by serving children who are among the most vulnerable in the community. Head Start is at the forefront of continuous improvement in Early Childhood Education and is a model of family engagement.

Early Head Start promotes healthy prenatal outcomes, enhances the development of infants and toddlers, and promotes healthy family functioning.

## Sequestration

### Significant Program Reduction

In March of 2013 Congress did not come to agreement on a budget, which resulted in automatic 5% cuts widely known as "sequestration". Our local Head Start program lost a total of 53 spaces for children. The budget cuts also forced us to lay off staff and end contracts.

Hundreds of families are on the waiting list for our local Head Start program. We serve approximately 73% of eligible preschool-age children and 14% of eligible infants and toddlers in the county as determined by federal poverty guidelines. Federal poverty thresholds are extremely low. For example, the maximum income for an eligible family of four is \$23,550 a year. In practical terms, poverty is not only determined by income alone; hundreds of families who are not income-eligible seek our services every year. They are struggling and although they do not meet the income guidelines most of these families lack security and/or stability. There are over one thousand families on the waiting list at all times. Many of these families do not meet the income-eligibility guidelines.

### Community Support

We would like to thank our community for speaking out about sequestration cuts and stepping up to provide concrete support to the program. The media helped educate our community about the ways that sequestration impacted Head Start children. Mission and State, a local web-based news outlet, created a wonderful video about the effects of the cuts. Many individuals supported our "book drive", and individual donors came forward to make sure the program remained strong.



# Ready for Success

## Prepared for Kindergarten

519 Head Start children went to kindergarten in the Fall of 2013. An overwhelming majority of these children were rated "kindergarten ready" based on the California Department of Education, 2012 Desired Results Development Profile (DRDP):

- 87% were rated kindergarten ready for language and math development
- 91% were rated kindergarten ready in cognitive and social development

## Qualified and Skilled Teachers

- 100% of Head Start teachers have state teaching certification
- 45% have Bachelor's degrees

A sample of preschool classroom observations using the Classroom Assessment Scoring System (CLASS) resulted in the following aggregate scores:

- Emotional Support = 6.10
- Classroom Organization = 5.89
- Instructional Support = 2.92

CLASS™ is an observational instrument developed at the University of Virginia to assess classroom quality in PK-12 classrooms. Scoring 1-2 is low range, 3-5 mid-range, 6-7 is high range.

## Enrollment Statistics: 2012 – 2013

### Total Enrollment


The program maintained full enrollment during the year. We coordinate with State preschools, school districts and the Child Care Planning Council to maximize the reach of school readiness and parent support services throughout the county.

### Full Day Care

373 families, or 34% of enrolled families, were provided with full-day childcare so parents could go to work.

### Enrollment by Age

Three and four year-olds comprised over 80% of enrollment.




## English Language Learners

Six out of every 10 children served come from households in which English is not the home language.

## Health Care and Treatment

- 97% of children were up to date on their Preventative Schedule of Primary Health Care with their doctor.
- 94% of enrolled children received a dental exam
- 400 children needed dental treatment
- 374 of those children (94%) received treatment for dental decay



## Early Identification and “Universal Design”

The Program is universally designed for all children, including those with special needs. Five classrooms employ a team teaching approach with special education teachers. This provides an inclusive natural setting for children with more involved disabilities.

- A total of 164 children (14%) had a diagnosed disability such as language delay, autism or intellectual disability
- 29% of the disabled children in Head Start were identified by staff

Fifty-six children qualified for Special Education services. These children were identified by CAC teachers during early screenings.

105 children needed special behavioral support. These children received mental health services in the classroom setting through a contract with Santa Barbara County Alcohol Drug and Mental Health Services.

## Parents are a Child’s First Teacher

Staff members create a welcoming environment and engage parents in the program by building positive relationships. Parents voluntarily participate in monthly parent meetings, parent workshops and conferences as they grow together with their children and strive for their own goals for a better life.



## 2014 Federal Review Results

A monitoring review of Community Action Commission Head Start and Early Head Start Programs was conducted by the Health and Human Services Department in January 2014. No area of noncompliance was found during the course of the review.

## 2013 Research and Special Projects


# Financial Report

2012-2013 Funding Source


